- 2. The registered office of the company will be situated in Uganda.
- The objects for which the company is established are "
 - To spread the Gospel of Jesus Christ to all nations and establishing churches.
 - 2. To train children, youths and adults to spread, propagate and communicate the gospel of Jesus Christ through evangelism and social works.
 - 3. To establish schools, institutions, universities and manage community development schemes and projects for orphans, widows and disadvantaged people.
 - 4. To share God's love in tangible and practical forms by bringing healing to suffering souls, bringing hope to the hopeless and raising a new generation who can transform communities
 - 5. To establish churches and conduct revival meetings, camps, numerical crusades, children rallies, public talk shows and to organize Christian concerts, galas, movies, for the purpose of spreading the gospel of Jesus Christ and promoting the word of God.
 - 6. To support South Sudanese and Sudanese refugees, orphans and widows through a broad range of partners, but will always include local churches in administration of humanitarian assistance.
 - 7. To recruit, train and place skilled personnel who are capable of and have the desire to present the gospel of Jesus Christ alongside their basic skills.
 - 8. To solicit, administer scholarships and provide theological leadership trainings and capacity building to clergy and lay people.
 - 9. To devise ways and means of making the Company self-sustaining, self-sufficient and selfpropagating.
 - 10. To receive and administer gifts, offerings, grants and other contributions for the work of relief, rehabilitation, reconstruction and development of the church, community and the country at large.
 - 11. To receive donations, gifts and offerings of all kinds for such promotion for the objectives of the Transformation Company
 - 12. To procure the mission to be registered or recognized in any other place, state and by any foreign country.
- 4. The liability of the members is limited.
- 5. Every member of the company undertakes to contribute to the assets of the company if it is being wound up while he or she is a member, or within one year afterwards, for payment of the debts and liabilities of the company, contracted before he or she ceases to be a member, and the costs, charges and expenses of winding up the company and for the adjustment of the rights of the contributories among themselves, such amount as may be required, not exceeding UGX 500,000.
